**Q16** STFC stands for Science and Technology Facilities Council. The marked-up proof proposes a correction in which the acronym STFC is defined at first use.

**Q17** CFC stands for Changfu Centre which is another name for the building. The company WWW site uses the acronym CFC and therefore we propose that the address be left as it is.
